ORDINANCE 2026-10

**AN ORDINANCE AMENDING CHAPTER 112
OF THE CODE OF ORDINANCES**

WHEREAS, Indiana Code § 7.1-3-31 authorizes the establishment of a Designated Outdoor Refreshment Area; and

WHEREAS, on the 17th day of June, 2024, the Town Council did adopt Ordinance 2024-10, which created “Chapter 112 – Designated Outdoor Refreshment Areas” in the Code of Ordinances of the Town of Brookville, Indiana and established the Town of Brookville “Downtown DORA”;

WHEREAS, on the 26th day of July, 2024, said “Downtown DORA” was approved by the Indiana Alcohol and Tobacco Commission;

WHEREAS, the “Downtown DORA” was previously amended on the 2nd day of September, 2025 by Ordinance 2025-15 and said amendment was subsequently approved by the Indiana Alcohol and Tobacco Commission;

WHEREAS, the Town of Brookville has received a “Letter of No Objection” from the St. Thomas Evangelical Lutheran Church located at 823 Franklin Avenue, Brookville, Indiana 47012 and said letter makes it possible for the modification of the “Downtown DORA” boundary which will allow an additional business to participate in the “Downtown DORA”. The “Letter of No Objection” from the St. Thomas Evangelical Lutheran Church is attached to this Ordinance, marked as Exhibit “A”, and is incorporated herein by reference;

WHEREAS, one (1) additional business, El Reparó, desires to participate in the “Downtown DORA” as a Designated Permittee;

WHEREAS, in order for this business to participate in the “Downtown DORA”, the “Downtown DORA” boundary must be amended. Said amended boundary is described in the § 112.04, below, and shown on the map attached to this Ordinance which is marked as Exhibit “B” and incorporated herein by reference; and

WHEREAS, the Town Council desires to amend §§ 112.04 and 112.09(A) of Chapter 112 and to amend the “Downtown DORA” boundary in order to allow El Reparó to participate in the “Downtown DORA” as a Designated Permittee upon approval of the Indiana Alcohol and Tobacco Commission.

NOW, THEREFORE, BE IT ORDAINED, by the Town Council of the Town of Brookville, Indiana, that Chapter 112 of the Code of Ordinances of the Town of Brookville, Indiana shall be amended to read as follows:

1. §§ 112.04 and 112.09(A) of Chapter 112 of the Code of Ordinances of the Town of Brookville shall be amended to read as follows (added language underlined; removed language ~~stricken~~):

TITLE XI: BUSINESS REGULATIONS
Chapter 112. Designated Outdoor Refreshment Areas

§ 112.04 Downtown DORA Boundary

The downtown area depicted in Exhibit “A”, attached to the Ordinance creating this Chapter and is incorporated herein by reference, is designated as the Downtown Brookville Designated Outdoor Refreshment Area (the “Downtown DORA”). The boundaries of the Downtown DORA by street address and direction are as follows:

Beginning at the intersection of Cliff Street and West 9th Street (Border #1) and moving East to the intersection of East 9th Street and ~~Main~~ Church Street (Border #2). Thence moving South to the intersection of Church Street and an unnamed alleyway (Border #3) and thence West to the intersection of the unnamed alleyway and Main Street (Border #4). Thence moving South to the intersection of Main Street and 6th Street (Border #3 #5) and then East to the intersection of East 6th Street and Church Street (Border #4 #6) and then South to the intersection of Church Street and East 5th Street (Border #5 #7) and then East to the intersection of East 5th Street and Franklin Avenue (Border #6 #8). Moving then South to the intersection of Franklin Avenue and East 4th Street (Border #7 #9) and then West to the intersection of East 4th Street and an unnamed alleyway (Border #8 #10). South along said unnamed alleyway to the intersection of the unnamed alleyway and East Third Street (Border #9 #11). Then moving West to the intersection of West 3rd Street and Progress Street (Border #10 #12) and then North to the intersection of Progress Street and West 7th Street (Border #11 #13) and then West to the intersection of West 7th Street and Cliff Street (Border #12 #14). Finally, from Border #12 #14 north along Cliff Street to its intersection with East 9th Street at Border #1.

§ 112.09 Proposed Designated Permittees of Downtown DORA

(A) The proposed and/or potential Designated Permittees of the Downtown DORA, pending each’s interest, application, and approval shall include, but not be necessarily limited to:

- (1) Veterans of Foreign Wars Post 2014
- (2) Brookville Bowling Lanes
- (3) Fraternal Order of Eagles #1129
- (4) Third Place
- (5) Pioneer Restaurant and Lounge
- (6) Knights of Columbus #1010

- (7) Hilltop Restaurant and Sports Dining
- (8) Nixie's Burgers
- (9) La Calaca Mexican Bar & Grill
- (10) El Reparó


2. The "Downtown DORA" boundary shall be amended as described in § 112.04, as amended, and as shown on the attached Exhibit "B", which is incorporated herein by reference.

3. This Ordinance is subject to the approval of the Indiana Alcohol and Tobacco Commission and shall not be effective until said approval has been obtained.
